CHEMOIL 3Q 2007 REVENUES UP 31 PER CENT BUT POSTS US\$2.5M LOSS

- Higher volumes reflect underlying strength of business operations
- Earnings result reflects profit warning issued in September 2007

Singapore, November 6, 2007 -- SGX Mainboard-listed Chemoil (SGX-ST: CHEL.SI) today announced its financial results for the 3rd quarter of the 2007 financial year (3Q2007). Revenue showed a growth of 31.2 per cent to US\$1.6 billion compared to US\$1.22 billion in 3Q2006. The revenue performance in this quarter was driven largely by higher sales volumes in Panama, New York and Houston, as well as higher cargo sales. For the first nine-months of 2007 (9M2007), revenue stood at US\$3.91 billion, approximately 20 per cent higher than the previous year.

For 9M2007, we posted a net profit of US\$15.9 million while our 3Q2007 posted a net loss of US\$2.5 million. As disclosed in our profit warning in September 2007, the loss for 3Q2007 was mainly brought about by the hedging results during the first part of the 3rd quarter 2007 wherein there was a lack of correlation between the price movements of the crude oil hedges and the physical fuel oil inventory, a risk that is inherent in its business. The profit warning also indicated that the disruptions experienced in the floating storage facilities in Singapore that had its primary impact in 2Q2007 also had residual effects in the 3rd Quarter.

Chemoil's Executive Chairman and CEO, Robert V Chandran said: "We need to push ahead and it is vital that we learn from this quarter and keep moving forward. We have sold the VLCC vessel at a profit of \$6.5 million and are gearing up to run our land based storage terminal in Jurong soon.

Mr Chandran added: "The losses sustained in 3Q represent a short term disconnect in the petroleum markets. I believe that our business model is robust and will generate shareholder value and growth in the long term as we have done in our 25 year history."

Mr Chandran emphasized: "We have made several moves to strengthen our global leadership in bunkering -- in Panama, we are planning to build a new multi-fuel storage terminal at Cristobal. In the Antwerp-Rotterdam-Amsterdam (ARA) region, we have acquired a substantial ownership share in Burando Holding which owns 21 barges and a terminal in Rotterdam. These moves are part of our long-term strategy to realize better profitability by owning key assets at every step of the supply chain in all our markets."

Continuing he said: "Chemoil is also now in discussions with leading international bank JP Morgan to co-develop new solutions for customers that involve sophisticated risk management solutions and physical product fulfillment globally."
